

#### NOTES

#### A. METHOD OF APPLICATION

- (1) Letters/emails from both Proposer and Seconder should accompany this form, stating fully the position of the Candidate socially and otherwise, his qualifications for membership, and the length of time they have known him, which should not ordinarily be less than two years.
- (2) It would be of assistance to the Committee if the Candidate could also be supported by Members other than the Proposer and Seconder.
- (3) Applicants (aged 18-24 who apply for membership on leaving a Public school or a school approved by the committee) may only be proposed by their Head of school. No Seconder is required.
- (4) The son of a Member need only be proposed by his father. No Seconder is required.
- (5) A Candidate's Proposer and Seconder must have been members of the Club for at least two years.
- (6) A Candidate may be required to attend an interview.

#### B. CATEGORIES OF MEMBERSHIP AND SUBSCRIPTIONS

The entrance fee shall be a sum equivalent to one year's subscription in the category in which the Candidate joins subject to a minimum of £700.00.
